

# PARTS FOR TRUCKS/GROTE DAYTONA 500 GIVEAWAY

## **SWEEPSTAKES RULES AND REGULATIONS**

- 1. Eligibility:** The Parts for Trucks/Grote Daytona 500 Giveaway is open to legal residents of Canada. Entrants must be 21 years of age or older in order to qualify. This Sweepstakes is subject to federal, state, and local laws and regulations and void where prohibited by law. Parts for Trucks's employees, its subsidiaries, affiliates, suppliers, partners, advertising and promotion agencies, and directors (collectively the "Employees"), as well as members of an Employees' immediate family and/or those living in the same household of Employees are ineligible to participate in the Sweepstakes.
- 2. Sponsorship.** The sponsor is Parts for Trucks ("Sponsor"), located at 15 MacDonald Ave, Dartmouth. Sponsor will conduct the Sweepstakes substantially as described in these Official Rules.
- 3. Agreement to Rules:** By entering this Sweepstakes, the Entrant ("You") agrees to abide by the Sponsor's Official Rules and decisions, which are fully and unconditionally binding in all respects. The Sponsor reserve the right to refuse, withdraw, or disqualify any entry at any time at the Sponsor's sole discretion. By entering this Sweepstakes the You represents and warrants that You are eligible to participate based on eligibility requirements explained in the Official Rules. You also agree to accept the decisions of the Sponsor as final and binding as it relates to the content of this Daytona 500 Giveaway Sweepstakes.
- 4. Daytona 500 Giveaway Entry Period:** This promotion begins on September 1, 2022 at 12:01 (AST) and ends on November 30, 2022 at 23:59 (AST). To be eligible for the Sweepstakes, entries must be received within the specified Entry Period.
- 5. How to Enter:** In order to qualify for an entry, \$100 before tax in Grote product must be purchased. For every \$100 in product will give 1 entry, i.e. \$435 in product will be 4 entries. Customers with Parts for Trucks accounts will be automatically entered into this random draw. Cash customers will have to fill out their information with our counter staff. Entries can be made in store or online. Incomplete entries or those that do not adhere to the Official Rules or specifications will be disqualified at the Sponsor's sole discretion. Fraudulent methods of entry or circumvention of the rules may result in the Sponsor invalidating your entries and removing them from the Sweepstakes at the Sponsor's sole discretion.
- 6. Prizes:** The Sweepstakes is for two separate prizes. One prize package will be awarded to an online entry, the other to an in-store entry. Each winner will receive a Daytona 500 package that includes tickets for two(2) to races on February 18 & 19, 2022, hotel accommodations February 17-20 (3 nights) at the Hilton Oceanfront Resort, and 2 travel gift certificates of \$1000, to go towards flights to Daytona. Approximate prize value of one package is \$8500 CAD. The actual/appraised prize value may differ at the time the prize is awarded. There shall be no cash or other prize substitution permitted except at the Sponsor's discretion. The prize is non-transferable. The Winner, upon acceptance of the prize, is solely responsible for all expenses related to the prize, including any other travel expenses. The Winner shall not transfer assignment of the prize to others nor shall the Winner request the cash equivalent or prize substitution. The Sponsor will notify the Winner(s) by phone call or email within five (5) business days following Winner selection. The Sponsor is not responsible for nor shall have no liability for Winner's failure to receive notices due to email security settings that may cause notifications to be marked as spam or junk email. Nor shall be Sponsor be liable for the Winner's provision of incorrect or otherwise non-functioning contact information. If the Winner 1) fails to claim the prize within 3 business days from the time the award notification was sent, 2) is found ineligible, or 3) does not complete and return an executed declaration and release within the specified timeframe, the prize may be forfeited and an alternate Winner may be selected. Terms & Conditions: In its sole discretion, the Sponsor reserves the right to modify, suspend, cancel, or terminate the Parts for Trucks/Grote Daytona 500 Giveaway, should non-authorized human intervention, a bug or virus, fraud, or other causes beyond the Sponsor's control, impact or corrupt the security, fairness, proper conduct, or administration of the Sweepstakes. The Sponsor, in the event of any of the above issues, may determine the Winner based on all eligible entries received prior to and/or after (if appropriate) the action taken by the Sponsor. Individuals who tamper with or attempt to tamper with the operation or entry process of the Sweepstakes or website or violates these Terms & Conditions will be disqualified by the Sponsor in its sole discretion. In its sole discretion, the Sponsor has the right to maintain the integrity of the Sweepstakes, to void votes for any reason.
